REGULAR SESSION/ CALL TO ORDER / PLEDGE OF ALLEGIANCE / ATTENDANCE

Board Chair Laurie Danzuka called the regular session meeting to order at 2:30pm followed by the Pledge of Allegiance. The Board Secretary documented the Board attendance.

2022/2023 JCSD 509J BOARD OFFICER NOMINATIONS Board Chair

Board Chair Danzuka called for nominations for a new Board Chair.

Jamie Hurd nominated Kevin Richards for Board Chair. With no further nominations, a vote was taken – motion passed unanimously for 2022-2023 Board Chair Kevin Richards – **Approved 5/0**.

Laurie Danzuka turned the meeting over to new Board Chair Kevin Richards.

Vice-Chair

Board Chair Richards called for nominations for 2022-2023 Vice-Chair.

Jamie Hurd nominated Courtney Snead for Vice-Chair. With no further nominations, a vote was taken – motion passed unanimously for Courtney Snead 2022-2023 Vice-Chair – **Approved 5/0**.

Director Jamie Hurd and Superintendent Jay Mathisen took a moment to recognize outgoing Chair Laurie Danzuka for her hard work and dedication.

Board Chair Kevin Richards proceeded to the agenda adoption.

✓ 2022-2023 Board Leadership Schedule

Superintendent Jay Mathisen introduced the discussion around board leadership meetings, whether they want to meet on the same days and time (Tuesday, prior to the Board Meeting at 9:00am).

Discussion took place and the board agreed that board leadership meetings for 2022-2023 would be held on the same days and time (Tuesday, prior to the Board Meeting at 9:00am) as the previous year. Board Secretary will finalize the schedule, rotate board members each month, send out the schedule and send calendar invites. Discussion also took place about potential times that board members may want to visit schools with the superintendent.

✓ Dual Language Update

Superintendent Jay Mathisen presented on the Dual Language Program. He shared that the lottery was held and we have affirmed thirty-seven of the forty-four slots; they are 'good-to-go' and those on the waiting list have been notified. Communication continues, to fill the native-Spanish speaking positions and Superintendent Mathisen will continue to keep the board informed.

✓ Summer School Update

Superintendent Jay Mathisen shared the ESY summer school update.

✓ Fall Opening Planning

Superintendent Jay Mathisen shared about the fall opening plans, referring to the schedule provide on pages 11-15 of the board packet. Discussion took place about previous years plans and the plans for this year. He shared that August 29, 2022 will be the all staff welcome back luncheon and the board is welcome to attend.

Discussion took place about a potential opening speech by the Board Chair to welcome staff back.

Discussion took place about the board members possibly meeting the new 2022-2023 principals; various options were discussed; Superintendent Mathisen will invite them to the August board meeting and work to arrange a more informal meeting.

Objective criticism of operations and programs may be heard, but no complaints concerning specific personnel, the visitor will be directed to the appropriate means for filing complaints as necessary.

Superintendent Mathisen explained that the CFO would bring the financial report to the August meeting, which is why it is crossed off the agenda.

Jamie Hurd motioned to approve the consent agenda as presented; motion passed unanimously – **Approved 5/0**.

B. OSEA Bargaining Agreement - 2022-2025

Vice-Chair Courtney Snead spoke of her experience on the bargaining team this year - sharing it was a very positive experience, the best bargaining unit she has experienced to-date.

Superintendent Mathisen agreed with Vice-Chair Snead's assessment of the bargaining team and summarized the agreement, explaining this agreement is for three years 2022-2025, after the second year, we have a financial reopener around cost of living allowance (COLA), insurance cap, and one language item.

Vice-Chair Courtney Snead motioned to approve the OSEA Bargaining Agreement - 2022-2025; motion passed unanimously – **Approved 5/0**.
