REGULAR SESSION MEETING MINUTES

BOARD OF DIRECTORS ATTENDANCE: Chair Kevin Richards, , Laurie Danzuka, Jacob Struck and Regina Mitchell

CALL TO ORDER / PLEDGE OF ALLEGIANCE / BOARD MEMBER ROLL CALL

Board Chair called the meeting to order at 6:00pm followed by the Pledge of Allegiance. Board secretary noted board member attendance for the record.

AGENDA ADOPTION

Board Chair Kevin Richards asked if there are questions or comments on the agenda, and called for a motion to adopt the agenda.

Laurie Danzuka moved to adopt the agenda as presented; motion passed unanimously – **Approved 4/0.**

INFORMATION / PRESENTATIONS / REPORTS / COMMUNICATION / DISCUSSION ITEMS

2024/2025 JCSD 509J Board Officer Nominations

Board Chair Kevin Richards asked for nominations for the 2024-2025 JCSD 509J board officers.

Laurie Danzuka nominated Courtney Snead for Board Chair, noting that even though Courtney is not present, past practice has been the vice chair move into the chair position the following

year. With no other nominations for board chair a vote was taken and passed unanimously – **Approved 4/0.**

Laurie Danzuka nominated Jacob Struck for the Vice Chair position. Jacob Struck (temporarily attending remotely) accepted the nomination, with no other nominations for vice chair, a vote was taken and passed unanimously — **Approved 4/0.**

Kevin Richards continued to preside over the meeting in the absence of Chair Courtney Snead and Vice Chair Jacob Struck attending remotely temporarily.

2024-2025 Board Leadership Schedule

Superintendent Jay Mathisen explained that the current schedule for board leadership is the Tuesday morning, a week prior to the board meeting at 9am, the meetings take place in his office. This agenda item is for board members to have a discussion about the day and time and if desired, change it for the new year. Discussion took place and the board members decided to keep as is. Superintendent Mathisen said we will create a schedule with rotating board members, send out calendar invitations and bring a copy of the calendar to the August meeting.

Budget Calendar (for 2025-2026)

Superintendent Jay Mathisen directed board members to page 3 of the board packet explained the 2025-2026 budget calendar with a commitment that leadership has heard the request of the board members and will have a draft of the budget to them well before May 12, 2025 - the scheduled first budget committee meeting.

ODE Coaching and Support Grant

Assistant Superintendent Shay Mikalson provide the update on the ODE Coaching and Support Grant. He explained that the grant has been executed in the amount of about \$2.6 million; Laurie Danzuka is representing the board's perspective in the small stewarding team, Superintendent Jay Mathisen and teacher representative Jodi Galyen will also be on the team. He also shared that he continues to meet with ODE on a regular basis in person and via Zoom. They will meet on July 30, 2024 in Eugene and we have invited ODE to come to the district for the site visit during the new teacher induction on August 20, 2024 that will include a tour of the Warm Springs Museum. Melinda Boyle will send out the schedule of the new teacher induction and tour day.

Vice Chair Jacob Struck entered the room to attend the rest of the meeting in-person.

In the absence of new Board Chair Courtney Snead, newly appointed Vice Chair Jacob Struck presided over the rest of the meeting; he asked for the public comments.

Objective criticism of operations and programs may be heard, but no complaints concerning specific personnel, the visitor will be directed to the appropriate means for filing complaints as necessary.

Written comments must be received online (via the comment link on the agenda) by **1:00 pm** [the date of the board meeting] and may be read during the public comment section of the meeting. Comments or complaints regarding specific people or personnel WILL NOT be accepted, please refer to the district complaint policy.
